Key Responsibilities

He/she will work closely with the team to conduct in-depth due diligence and execute equity and quasi-equity investments. He/she will demonstrate strong skills in financial analysis and modeling.

- Update Gaia Impact's investment management system and participate in **deal flow review meetings**.
- Build and maintain a robust pipeline of investment opportunities aligned with Gaia Impact's investment strategy.

2. Investment Due Diligence & Deal Execution

- Assist the team in conducting in-depth due diligence, including financial analysis, multi-factor company valuation, social/environmental impact assessment, market research, and business model review.
- Develop financial model forecasts, scenarios and sensitivities based on corporate business plans.
- Contribute to the preparation and presentation of investment memos to the Investment Committee.
- Collaborate with the team and advisors in the **negotiation and structuring of deals** down to financial close.
